CAAEEAS ('The Association') is a not-for profit Members Association in Chester, and we take our responsibility for the Protection of your personal data seriously.

This privacy notice tells you what to expect when we collect personal information.

What data will we hold on you?

We will only collect such personal data from you as we need in order to be able to contact you by telephone, digital communication, and by post.

How will we keep your data?

Your data will be held electronically on secure 3rd Party Servers

Our Promise to you

We will process your personal details lawfully, fairly and transparently

How will you collect my information?

You will complete your own page of information on joining 'The Association'

Why will we hold your data?

Your data will be kept on our records for the purposes of keeping you informed about the activities of The Association, and for promoting your personal business services.

How will we keep your details up to date?

We will endeavour to keep up to date but we do rely on you to advise us if your details change

How long will we keep your data for?

Your data will only be kept for so long as you remain a member, you can request for it to be deleted at any time, but be aware that you will automatically cease to be member at that time.

Disclosure of Personal Information

Your business information will be open to members of The Association, and the general public.

Your rights

Under The General Data Protection Regulation you have rights as an individual which you can exercise in relation to the information we hold about you.

You have a right to Complain to the Information Commissioners Office if you consider that we have breached our data obligations.

Visitors to our websites

When someone visits caaeas.co.uk we use a third party service, Google Analytics, to collect standard internet log information and details of visitor behavioral patterns. We do this to find out things such as the number of visitors to the various parts of the site. This information is only processed in a way which does not identify anyone. We do not make, and do not allow Google to make, any attempt to find out the identities of those visiting our website. If we do want to collect personally identifiable information through our website, we will be up front about this. We will make it clear when we collect personal information and will explain what we intend to do with it.

Use of cookies by The Association

We use Cookies on our website

Search engine

Our website search and decision notice search is powered by an external agency. Search queries and results are logged anonymously to help us improve our website and search functionality. No user-specific data is collected by The Association or any third party.

Security and performance

The Association uses a third party service to help maintain the security and performance of our websites. To deliver this service it processes the IP addresses of visitors

If you contact us via social media

The Association has accounts with Facebook and other Social Media platforms, and these 3rd parties will have their own appropriate filters and security controls.

If you email us

Any email sent to us, including any attachments, may be monitored and used by us for reasons of security and for monitoring compliance with office policy. Email monitoring or blocking software may also be used. Please be aware that you have a responsibility to ensure that any email you send to us is within the bounds of the law.

Your rights

Under the General Data Protection Regulation, you have rights as an individual which you can exercise in relation to the information we hold about you.

Complaints or queries

The Association tries to meet the highest standards when collecting and using personal information. For this reason, we take any complaints we receive about this very seriously. We encourage people to bring it to our attention if they think that our collection or use of information is unfair, misleading or inappropriate. We would also welcome any suggestions for improving our procedures.
